We share observations conducted, review all negotiated indicators from the Marshall Rubric as well as what evidence is needed to be observable to receive a certain score etc. We also pair evaluators up to do a minimum of one observation together each year. During this time they observe, collect evidence and score the observation collaboratively to ensure consistency between evaluators.
