



## 2024-25 Title I Part A, Title I Part D, Title II Part A, Title IV Final Allocation Changes

On January 31, 2025, the NYSED Office of ESSA-Funded Programs posted final 2024-25 allocations for the Title I, Part A; Title I, Part D; Title II, Part A, and Title IV programs for all Local Education Agencies (LEAs). Updated allocations will be available online at: <http://www.nysed.gov/essa/allocations-poverty-data-and-student-counts>.

The adjustment from preliminary allocations posted in July 2024 to the final allocations that were posted in January 2025 is due to changes in student count data and state-level allocations calculated by the United States Department of Education.

LEAs should visit their NYSED Grants Finance page by:

2. Selecting the county where the LEA is located, then
3. Selecting the LEA name, then
4. Selecting the “2024-25 – ESSA Allocation Report”

The 2024-25– ESSA Allocation Report will provide your LEA with information such as updated Title I, Part A allocations, updated Title I, Part D allocations, updated Title II, Part A allocations, updated Title IV allocations, approved budget amounts, and available carryover funds so adjustments to budgets for these Titles for the 2024-25 school year can be made in a timely manner. Please note, once final allocations are posted, Grants Finance needs time to update the ESSA Allocation Report.

### **IF YOUR 2024-25 ALLOCATION HAS INCREASED:**

If the amount of the district’s final allocation **increased** you can choose to:

1. Submit a Budget Amendment (FS-10A) to access the additional funds for use during the current project period, OR
2. Take no action and carry over the increase into the 2025-26 school year. Please note, that for Title I Part A funds, carryover funds cannot exceed 15% of the 2024-25 allocation.

LEAs may access carryover funds from 2023-24 to increase the 2024-25 budget total via the same Budget Amendment (FS-10A) process.

### **IF YOUR 2024-25 ALLOCATION HAS DECREASED:**

If the amount of the district’s final allocation **decreased**:

1. The LEA will need to submit a Budget Amendment (FS-10A) to adjust the approved budget to match the total amount of funds available. The amount of funds available is the sum of the final allocation amount plus any available carryover funds from 2023-24.
2. If an amendment is not submitted by June 1, 2025, the district will be contacted at the end of the 2024-25 school year and asked to submit an amendment (FS-10A) to bring the project budget in line with the amount of available funds for 2024-25.
3. If an amendment is not submitted by August 31, 2025, the LEA's final expenditures for 2024-25 will be decreased to the total available amount through the final expenditure report (FS-10F).

Please note: In some cases, the amount of carryover funds from 2023-24 may be sufficient to offset the reduction in the final allocation amount and an FS-10A may not be needed.
