1	Change in Maximum Approved Enrollment	After several months of growth and financial planning, we are no longer planning to double the size of our Downtown Elementary School to a four cohort model serving 660 students. Instead, we will be expanding our elementary school to 510 students, a 3 cohort model, at full scale, through a more gradual growth rate of one cohort each year, starting with one additional cohort of Kindergarten this Fall (total 85 Kindergarten students, up from 55). We believe this new growth model aligns best with our program quality goals, financial sustainability goals while still enabling us to bring our program to more students. All BPCS elementary schools will be aligned to this three cohort model.


