A revision requested by this charter school to amend the following Key Design Element from "A special focus on English Language Learners. In the Lower Manhattan neighborhoods of Community School District 2 that Great Oaks intends to serve, 10% of middle school students were classified as English Language Learners in 2011. Overall, one in three Manhattan residents is an immigrant and Advocates for Children estimate that there are at least 1,000 students in CSD 2 who are immigrants with an interrupted formal education. Alarmingly, while just under half of the city's Non-ELL students met the state's English language arts standards on the most recent state exams, only 11.6% of ELL students did so. Great Oaks intends to aggressively reach out to non-English speakers in Lower Manhattan and will set aside 25% of the seats in each lottery as an at-risk preference for English Language Learners. In addition, Great Oaks will implement an effective, research-based program that uses high-quality classroom instruction, extensive professional development for educators and high-dosage daily tutoring to help students who are English Language Learners and other at-risk student populations reach English proficiency and ultimately go on to college success" from its charter to " A focus on special populations. Great Oaks Kathleen Sherry Charter School will consistently surpass the district in which it resides in the percentage of English Language Learners, students eligible

for Free and Reduced Price Lunch, and students with disabilities. Great Oaks intends to aggressively reach out to non-English speakers, students with disabilities, and students eligible for Free and Reduced Price Lunch in Lower Manhattan and will set aside 25% of the seats in each lottery as an at-risk preference for English Language Learners. In addition, Great Oaks will implement an effective, research-based program that uses highquality classroom instruction, extensive professional development for educators and high-dosage daily tutoring to help students who are English Language Learners and other atrisk student populations reach English proficiency and ultimately go on to college success" beginning in the 2025-2026 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.

The application of this school is being reviewed for possible action at an upcoming Board of Regents meeting. You are receiving this notice since the school is located in your school district and/or your school is located in the same geographic region as the charter school seeking this proposed action. If you are not the school's district of location, as indicated above, nothing further is required. However, if you seek to provide public comment regarding this proposed revision, additional information on how to do so is provided below.

Please note that pursuant to Education Law §2857(1) and 8 NYCRR §119.4 (available at <u>http://www.p12.nysed.gov/psc/aboutcharterschools/lawsandregs/law.html</u>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. The hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 calendar days of receipt of this letter.

The charter school's district of location is required to provide the following required documentation to the Charter School Office:

- 1. A copy of the public hearing notice, at the **time of dissemination**.
- 2. Written confirmation that this hearing was held, no later than the **next business day** following the hearing.
- 3. Copies of any and all written records or comments generated from this hearing within **15 business days** after the hearing.
- 4. **A summary** (shown below) outlining the date and time of the hearing, the number of people who attended, the number of speakers, the number of people in favor, and the number of people opposed, and any comments received **in the following format**:
