Bainbridge-Guilford Central Schools have made a priority of improving school safety and security with most of their Smart Schools Bond Act allocation. With this application, Bainbridge-Guilford plans to close out those funds with two more security projects. With the first component of the plan, Bainbridge-Guilford wishes to improve the Emergency Classroom Notification system at the Greenlawn Elementary School. That building has an antiquated analog public address system that is failing. There are areas of the building that may not receive emergency messages. Additionally, there are areas of the building that receive the message, but at a very low level. Bainbridge-Guilford is proposing to replace that system with an IP based system in all classrooms and public spaces. These units will be routed through the computer network. In the event of an emergency, the system will work with the Emergency VOIP phone system to deliver the correct message to all the affected students. In the event a unit fails, the computer support personnel will be notified, and repairs can be completed. The second component of the application is the installation of emergency Lock Down controls and notification in all three buildings in the Bainbridge Guilford district. These units will allow staff members to press a single button to lock down the building. If there is an unauthorized individual approaching the building, the district can initiate a Lockdown. A Lockdown will lock all exterior access control doors, dial out to 911, initiate blue light strobes and send a message to designated staff and individuals. Additionally, visitors or staff members that may be approaching the building will be warned there is an incident in the building by exterior blue strobe lights. This will prevent visitors or staff members from approaching the building.
