Our buildings currently exceed the minimum speed standard bandwidth of 1000 Mbps for 2,357 students. This high tech security project requires additional switch hardware to support digital IP surveillance cameras throughout the district. The prior approved Smart schools project detailed additional fiber optic runs which increased the internal cross building connection speeds.

Each and every school in our system has safety plans in place for a variety of emergencies and, to ensure that each school continually meets our security expectations, security procedures are reviewed as needed and periodically throughout the year. In conjunction with this, we will be implementing additional physical security equipment to help facilitate this.

Our current camera/security system is inadequate and does not provide for optimum viewing of our school buildings and our high school athletic facilities required for the safety of our students and staff. The district currently has approximately 150 cameras that are comprised of both analog and digital formats. The security enhancements to the district will encompass the following areas; camera upgrades/additions, network switch gear to power cameras and video storage capabilities. The goal is to expand this system to provide additional security to protect our students and staff.
