Granville CSD intends to use the Smart Schools Bond to replace the existing network hardware to improve the connectivity of staff and student devices as well as VOIP phones and security cameras. Granville CSD is in the process of updating the security camera system, the installation of a voice over IP phone system and rolling out a 1:1 Chromebook initiative throughout the district. The current network has been maintained using E-Rate and local funding. With the additional demands on the network required by the updated security system, VOIP phone system, the 1:1 initiative, and normal replacement, alternative funds are necessary to make the needed network upgrades. The SSBA funds will be used to purchase core switches for each of the buildings, the edge switches that connect to the core switches, all the equipment needed to interconnect the switches and the buildings, software to configure and monitor the switches, installation, and configuration.

A big part of providing that consistency is having up to date network hardware handling the network traffic in the buildings before it exits the internal network and enters the internet. It is also important that each building have the same ability to access the internet. This plan is slated to upgrade all of the switches in each of the buildings, which is a key to providing equitable access to all of the students and staff.

Granville CSD has worked with vendors to assess the current wireless network and the supporting wired network. As a result, the number of WAPs has been increased to accommodate the number of wireless devices that are connecting to the network to access the internet. The funds from the SSBA will be used to refresh the wired network's network hardware that supports the wireless network which will allow Granville CSD to continue to add WAPs to support the increasing number of wireless devices that will access the internet using the school's Wi-Fi network.
