The current Elementary-Middle School is separated into two distinct schools, Elementary (K-5) and Middle (6-8). The current entrance into the Elementary and Middle Schools is located down the corridor from each of the main offices. The single entry presently allows uncontrolled access to each side of the building.

The proposed improvements relocate the main entrance to two separate secured entrances, one for the Elementary School and one for the Middle School. These new entrances will be located in the area of the existing offices.

To accomplish the locating of the secure entrances, the existing office areas need to be reconfigured to provide the secure vestibules and control of the same. Offices, staff areas, office support space and control points are relocated to provide the security required.
