There has been a lot of change in the world since our district prepared our original application. Due to declining enrollment and the ongoing pandemic, Johnstown would like to reduce some of the items in the original application and use those funds for critically needed High Tech Security. In our originally submitted plan the district intended to purchase interactive whiteboards, laptop devices, and storage/charging units for those devices. Since the plan was approved, the district closed one of their buildings which reduced the requirement for interactive whiteboards. Additionally, due to the pandemic, laptop devices that had been stored in classrooms have been distributed to students. This eliminated the requirement for the storage/charging stations.

Additionally, Pandemic Relief funds have been applied for to purchase additional one-to-one devices. Those devices will fill the requirement that was applied for in the original application.

Johnstown City School District wishes to ensure that all of their students attend a safe and secure school. The district has developed a comprehensive plan for that security and wishes to use Smart School funds to address some components of the plan.

The first component is Video Security. The district currently has limited video security coverage. The district wishes to purchase additional video cameras that will be used vulnerable areas both inside and on the campus of our buildings. District administrators will be able to monitor those areas as required and also have a video record of events that might occur. Additionally, the district wishes to purchase expanded video storage devices. Currently the storage capacity is very limited. Events are erased after a short time. The new equipment will give the district the ability to store all video recordings for an extended period. Additionally they can archive specific events or activities for future access.

A second component to the Security plan is Entry Control. A generation ago, schools were constructed with many doors to provide access to the buildings. Today, those doors are points of vulnerability possibly providing access to the building for people that shouldn't be there. Johnstown wishes to limit the access from the outside. Visitors will be directed to a designated entrance to the building. At that entrance, a door station will provide video and audio communication with the visitor. This will allow the district to confirm that the right people are entering the building for the correct purposes. No longer will everyone walk in the door and have access to all of the students and staff. Finally, additional doors will have equipment added which will allow the district monitor when they are opened and when compared to video security, by whom.
