By the school year 2018-19, we will upgrade our internet connection from 350 Mbps to 1.0 Gbps. This will exceed a minimum of 100 Mbps per 1000 students. This will enhance learning for students and improve the proclivity of staff. We have allocated district fund for this expenditure.

3. Describe how you intend to use Smart Schools Bond Act funds for high-speed broadband and/or wireless connectivity projects in school buildings.

MWCSO intends to spend the SSBA funds on the school connectivity infrastructure. Past two years, the District has invested in building a robust wireless infrastructure and increasing students’ and teachers’ access to desktop and laptop, Chromebooks, iPads, and other devices. In all schools, there are stationary and mobile computer labs, iPad carts, Chromebook Carts, interactive whiteboards and other display technologies. Based on these investments and our continuing refresh cycle of computers that are five years old, the most effective way to expend the SSBA fund is in building infrastructure, through replacing old switches, running new fiber between IDFs and MDF and upgrading wireless controllers with wireless access points.

This will also support our Google Classroom initiative and support online database access. This will provide 24\*7 learning for our students and staff.

With help of SSBA, we will install AC wireless access points in all our schools. This will support our Google Classroom initiative and allow students to learn emerging technology in a real-time environment.
