North Collins Central School District has a robust Aruba wireless system, including access points purchased in 2023 supporting the newest WiFi 6 protocol in every instructional space. We have a secondary redundant wireless controller supported by a uninterruptible power supply on backup generator power should the building suffer a loss of electrical service. This system supports over 50 simultaneous client connections on each access point, and with class sizes being below 30 we have no concerns of meeting current or future demands on the wireless network.

The North Collins Central School District uses Google Classroom as our learning management system, and as such we provide students with Google Chromebooks as part of our 1 to 1 device initiative. Google provides support for Chromebooks for 6.5 years after the device model is released. We purchase enough Chromebooks every year to replace at least 1/6th of our fleet of devices to ensure that all student and instructional staff's devices are currently supported and secure. This comes to approximately 125 Chromebooks being replaced each year. The district intends to purchase 125 Chromebooks each year through the Smart Schools Bond act in line with our 2022-2025 district technology plan. The total number of devices for the upcoming 23-24 and 24-25 school years come to a total of 250 Chromebooks that will be supported by our robust wireless system.

The district also intends to continue replacing aging classroom projector systems in line with our 2022-2025 district technology plan. To meet this goal at the end of the 24-25 school year requires replacing 12 projection systems with interactive displays each year through the Smart Schools Bond act in line with our 2022-2025 district technology plan. The total number of interactive displays needed for the upcoming 23 24 and 24-25 school years come to a total of 24. These interactive displays will be installed in locations with existing adaquate electrical service by our buildings are grounds and technology staff.

The shift to remote and hybrid learning models during the 2020-2021 school year brought about the implementation of our 1 to 1 device initiative. The continued yearly purchase of Chromebooks to support our 1 to 1 program provides for the expansion of student learning both inside and outside the classroom. The purchase of student and instructional staff Chromebooks to comply with our device replacement plan outlined in our 2022-2025 district technology plan allows for the reduction of and the bridging of learning gaps created during the response to the 2020 Covid-19 pandemic.

With students now having equitable access to instructional technology, there are no technology barriers to education due to economic status. Should there be future unforeseen circumstances such as inclement weather or a building emergency, the district will be prepared to provide remote learning to all students even if the school building is inaccessible. The purchase of Chromebooks to support the 1 to 1 Chromebook program also allows instructional staff to differentiate instruction to meet the needs of individual students learning styles who may not respond well to traditional teaching methods.

The replacement of aging projection system with interactive displays work hand in hand with our Chromebook and Google environment to provide a myriad of learning opportunities for all students. The interactive displays allow for a "Flipped classroom model" in which students interact with each other in the classroom by direct physical interaction with the display, or through remotely broadcasting their work on a Chromebook device to the display for the class to experience. ELL students and those with disabilities can utilize the interactive displays and Chromebook devices as alternate methods of communication, including available accessibility features such as text-to-speech, speech-to-text, and on screen keyboard.

Chromebook purchases supporting our districts 1:1 program will bring connectivity to all parents and familys in the district. Like a 'living' version of a textbook, chromebooks allow students, parents, and staff to communicate effectively and bridge communications gaps. The ability for students to use these devices to communicate with other schools via distance learning opportunities, applying to colleges and trade schools, and further their skills and knowledge is a key point to our students success. On the same note, having interactive displays in classrooms allow teachers to bring remote learning opportunities into the class with educational events such as the NASA outreach program and connecting with other schools across the world.

The North Collins Central School District has used the Google Classroom as our learning management system and has had a 1 to 1 device initiative for several years. Each year we work with our technology integration team to provide updates and new professional development for the Google environment. This includes in person training and online offerings as available through online resources. Regarding interactive displays, we provide access to Prometheans online training modules to all our staff, allowing them to do training as needed and at their pace for their interactive displays. When a new board is installed, our technology integrator and tech department work with staff that will be using the display to provide a tutorial and overview of functions. Throughout the year we provide updates as they come along and new integrations possible into the classroom such as student and staff device mirroring from their chromebook to the display to enhance learning.
