In the event of an emergency, communication with students and staff is of paramount importance. Traditionally, the Public Address systems in buildings use an analog system with ancient speakers located in classrooms. The systems were designed to provide daily announcements like the lunch menu and maybe an occasional school closing due to weather.

New York Mills Union Free School District has identified several vulnerable areas where the old system provides limited or no coverage. Today, if there were an emergency, staff and students would be vulnerable due to their inability to get the correct information. Shelter in place, or exit the building, or report to the main office. Ironically, the most vulnerable locations are hallways and large group instruction rooms. New York Mills is proposing to upgrade the equipment in those areas with additional IP based equipment. Including speakers and digital signboards, the district proposes to supplement the existing equipment and make sure that everyone gets the message.
