Not having access to in-classroom bathroom facilities has been a challenge for Waterville's Universal Pre-K 4 year old program. The logistics involved in frequent "whole-class" bathroom breaks has resulted in a significant loss of instructional time. This translates into 1.7 hours per day that will now be redirected to student learning. Presently, the two pre-Kindergarten classes (district-owned), located at Waterville's Memorial Park School, are 900 square feet. Following construction, the resulting spaces will still meet that standard. The plan is to have one bathroom shared by two classrooms, each with its own in-class access. The original estimated construction cost was \$100,000, or \$50,000 per classroom. The project was postponed for two years. In that time, the total cost escalated by \$20,000 and now the cost for this project is \$60,000 per classroom.
