**High-Tech Security Features**

The purpose of the original submission was to replace the existing surveillance system to ensure the security needs of the district are met. Since the original plan was submitted, the security needs of the district have increased and available security technology has improved. Because of these changes, the original submission no longer included all the necessary equipment to achieve this goal. An amendment was necessary to ensure that the new surveillance system met the needs of the district now and into the future. This includes replacing coax cable with network cabling throughout the building for the surveillance system. It also includes upgrades in functionality within the system by adding an improved NVR (network video recorder) which will allow for adequate storage for video footage. Additional cameras, including newer higher quality cameras, were also added as part of the amendment.
