☑ Group 1	In 2023-24 the Administration and Teachers' Association decided to apply for a variance that focused on a Self-
	Directed Plan to foster and promote the staff member's individual professional growth in closing learning gaps
	or social-emotional learning practices. Each self-directed plan will be written to be completed in one year. The
	teacher or team of teachers will determine a focus to help them develop lessons and strategies to close
	learning gaps or address social-emotional learning in their instruction. They will then work throughout the year
	to learn more and implement their learning during the school year. In the past, prior to APPR, the district found
	Self-Directed Plans to have great personal value to the teachers as they were able to choose the focus of their
	personal growth. By reimplementing this practice we would like to provide opportunities for teachers to work
	collaboratively, problem solve and try techniques to reach the many needs of their learners. Additionally, the
	work of the most recent years with observations has provided limited opportunity for growth with tenured
	teachers because the information normally captured during traditional observations for these experienced
	teachers is largely unchanging making it difficult to give feedback that improves instructional practice. With the
	self-directed plan, teachers will be reflective practitioners, who have the opportunity to rate themselves. John
	Hattie's research has shown that learners can be remarkably accurate at setting realistic growth targets for
	themselves and then assessing their own performance at meeting them. We have previously found that this is
	the case with teachers as reflective practitioners as well. With this form of review, it becomes a collaborative
	conversation rather than checkboxes. We know from prior experience that utilizing the SDP would provide
	teachers with authentic performance-based feedback that would provide teachers with actionable plans for
	improvement.
	This APPR variance will provide an opportunity for the evaluator to examine and evaluate elements from within
	the Danielson rubric beyond what is traditionally observed in a classroom visitation, such as planning,
	preparation, collegiality, collaboration, professionalism, and reflection on teaching practice. The evaluator will
	be able to compare the teacher's self-assessment to their own evaluation within the context of the Danielson
	rubric.

The parameters of the project will be approved if it addresses the District Goals as outlined in the Strategic Plan as well as anything addressing effective standards of instruction as outlined in the Danielson Rubric or any other research-based instructional practice that has evidence-based outcomes.

RHTA members may work alone on the SDP or collaboratively with other members of a grade level or content based team. If members work in a collaborative group, only one plan and evaluation needs to be collected, however each member will need to receive an informal observation. In the case that the members are normally co-teaching, an informal observation of the teachers can be done at the same time.

RHTA members may arrange an informal observation related to their plan with the administrator assigned to them. The documentation submitted regarding the SDP will serve as the pre-observation conference form to be reviewed during the pre-observation conference. The RHTA member(s) will discuss their SDP as related to the lesson and both the administrator and the member will sign off on the SDP. Should teachers want further feedback a follow up conference will be made available.

At the end-of-the-year evaluation, the RHTA member(s) will submit a final self-evaluation, discussing their goal, achievement and possibility for future needs.

Scoring will be as follows:

The Self-Directed Plan will be evaluated using the Danielson Rubric, and evaluators will score the project using any of the elements within Domains 2 and 3 of the Danielson Rubric that are observed.

The evidence that will be evaluated at the conclusion of the project may include, for example, student projects or assessment results, artifacts showing implementation of research-based professional learning, documentation from the observation and SDP review conversations and any other approved measures that show professional growth throughout the year. The project elements will be scored using a four-point rubric (4- highly effective, 3- effective, 2- developing, 1- ineffective.) The outcomes will provide a comprehensive measure of the teacher's knowledge and understanding of the SDP's impact on student learning. The evaluator will score evidence collected that aligns with the selected components of the designated rubric, using the standard rubric scale. Those components will be weighted equally and averaged to reach an overall score for the SDP. Both the Self-Directed Plan and observation will be conducted by the same

Annually, the district examines and interprets data to identify the top professional learning needs of teachers participating in an end-of-year survey. Additionally, evaluators will conduct a needs assessment to determine the necessary professional learning opportunities for teachers. The district will use this information collectively to provide targeted professional learning opportunities during opening days for teachers based on this data. The feedback from the professional learning days informs the district of ongoing professional growth and what would be best focused on in future professional learning projects. Furthermore, as research shows, the most effective model to provide professional learning is one where teachers learn in a cohort group, have the opportunity to try out what they are learning, and provide feedback to one another, hence the district's decision to allow teams to work in groups on this project. These learning and teaching experiences will be explicitly reflected in their professional learning project. We continue to enhance our district's professional learning plan to grow professional opportunities for teachers. Our differentiated model for professional learning continues to be successful in meeting the needs of our adult learners. In our model, expert teachers share best practices with their colleagues, problem-solve, and create support networks.

The professional learning project allows teachers to hone their skills and improve their practice through a systematic, organized approach to professional learning to support student growth and achievement. Through implementing the innovative variance and the professional learning project, the District can provide more targeted, specific professional growth opportunities to teachers based on the essential knowledge and skills each teacher identifies as a need or an area for improvement. Administrators will use the information gleaned from both a needs assessment and professional learning projects to develop professional learning opportunities that will help support teachers in the improvement of their practice which ultimately has a positive impact on student performance and achievement. On an annual basis, we will review the SDPs that the teachers have selected and determine whether those processes may be beneficial to a greater group. In working through this process, we may be able to identify areas of need and solutions based approach that we may be able to duplicate in other areas. We will monitor and assess this work so as to offer programs on a greater scale at the district level. For example, a selected teacher or group of teachers may read a book, implement strategies that are suggested and may glean positive results. Should this apply to another teacher or group of teachers, the concept could be shared through our Director of Instructional Programming or instructional coaches in order to realize those positive results on a greater scale.
